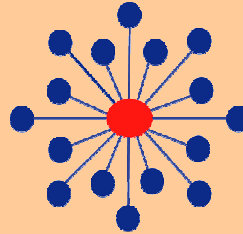

Medication Assisted Treatment

Workshop #1

Yngveld Olsen, M.D.

(recommended for Administrators)

This workshop will provide insight for administrators and policy makers into the utility, logistics and funding strategies for integration of medication based treatments into substance abuse services.

Workshop #2

Michael Fingerhood, M.D.

(recommended for Clinicians)

Michael Fingerhood is an experienced physician who operates a medical clinic for substance users, and HIV-infected individuals at Johns Hopkins Bayview Medical Center. In his workshop for clinicians, he will discuss the utility of medication-based treatments, how these can best be integrated with medical care and with psychosocial counseling, and how to access medication treatment for clients at community clinics that do not support this service.

Workshop #3

Marc Fishman, M.D.

(recommended for Clinicians)

Marc Fishman is an addiction psychiatrist who operates treatment programs for both adult and adolescent substance abusers. His workshop will focus on the utility of medication-based treatments and how these can best be integrated with psychosocial counseling. Counselors will be introduced to the most effective treatment plans for both adult and adolescent substance abusers presenting with a variety of substance use profiles and how to access medication treatment for clients at community clinics that do not support this service.

Jim Beiting, as Executive Director of Community Behavioral Health in Hamilton Ohio, has implemented incentive interventions agency-wide. His workshop for administrators and policy makers will emphasize the clinical and management benefits of using these interventions and provide insights into the strategies and logistics that can be used to introduce these techniques at the agency level.

Workshop #2

Ashli Sheidow, Ph.D.

Ashli Sheidow, Ph.D. is a faculty member at the Medical University of South Carolina, where she has developed and used motivational incentive techniques in community-based projects for substance using adolescents and their families. In her workshop, she will discuss the principles and practical methods for implementing motivational incentive procedures with substance abusing clients including adolescents. Information will include selection of target behaviors, reinforcers and schedules for best results.

Christine Higgins, M.A./Lori Petersen, M.S.W.

(recommended for Clinicians)

Christine Higgins is Dissemination Specialist for the Mid Atlantic Node of the CTN. She has extensive experience in training clinical staff in use of motivational incentives for improved treatment outcomes. In her workshop, she will discuss the principles and practical methods for implementing motivational incentive procedures with substance abusing clients. Information will include selection of target behaviors, reinforcers and schedules for best results.

Recovery Oriented Systems of Care

Workshop #1

(recommended for Administrators)

Roland Lamb is Director of the Office of Addiction Services in Philadelphia. In this role, he has spearheaded a living ROSC model that has turned a city-wide treatment system into a recovery-oriented support system. Mr. Lamb in his plenary talk will discuss the tenets and elements of a recovery-oriented system of care. In his workshop for administrators and clinicians, he will provide real world insights on how to create and sustain a recovery-oriented system of care.

Workshop #2

(recommended for Clinicians)

Michael Dennis, Ph.D. from Chestnut Health Systems, Indiana, has been at the forefront of research and development on the management of addiction as a chronic condition as well as long-term models of care for adult and adolescent substance abusers. His plenary talk will focus on findings from longitudinal research that support the need for long-term models of care and on research with Recovery Management Checkups (RMC) as a method for delivering long-term care. His workshop will provide more detailed information on Recovery Management Checkups and how this strategy can be implemented in real world settings to improve long-term outcomes.

Workshop #3

(recommended for Clinicians)

James McKay, Ph.D. from the University of Pennsylvania has been a leader in research on chronic care for addictions and has focused his research on use of telephone follow-up as a post-treatment intervention. His plenary talk will describe research background that supports long-term care and use of telephone follow-up methods to improve treatment outcomes. His workshop for clinicians will provide more detail on how to use telephone follow-up to improve long-term outcomes for substance abusers.
